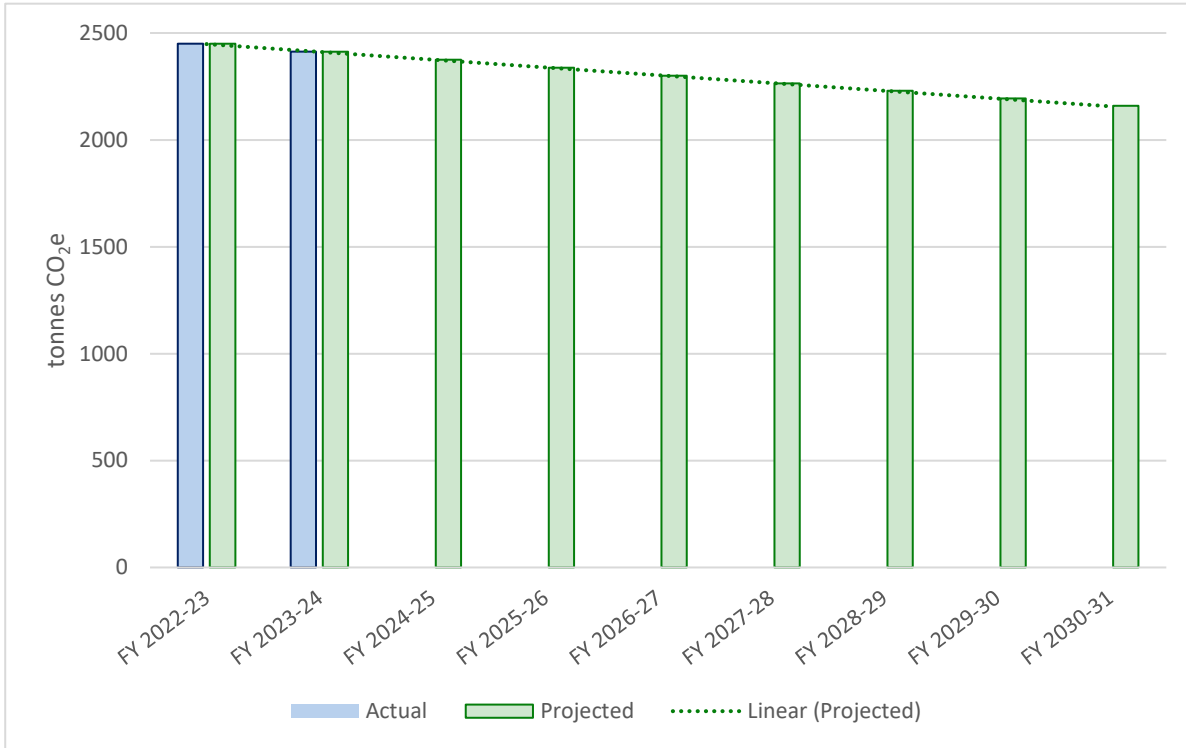

- Switch to green electricity tariff equating to -54.01 tonnes CO₂e, a 100% reduction of Scope 2
- Reduction in emissions related to 3PL Providers equating to -946.53 CO₂e, 46 % reduction of Scope 3 Subset 'Downstream Transportation and Distribution'
